Galveston Central Appraisal District is not a taxing unit as defined by Texas Tax Code § 1.04. The District does not levy ad valorem taxes, does not set tax rates, and does not issue tax bills. The District is funded by allocations

paid by participating in taxing units under Texas Tax Code § 6.06. Adoption or discussion of the District's budget does not directly result in any property tax bill or direct change to the property tax bill for a median-valued homestead property. Any property tax impact, if any, would be determined separately by the participating taxing units when those taxing units adopt their respective budgets and set their respective tax rates.

Appraisal District Budget Notice

Pursuant to Texas Tax Code §§ 6.06 and 6.062, the proposed GCAD budget includes the District's proposed positions, salaries, benefits, capital expenditures, and the estimated amount of the budget allocated to each participating taxing unit. The District is supported solely by payments from the local taxing units served by the District. A copy of the proposed budget is available for public inspection at GCAD, through the participating taxing units as required by Chapter 6, and/or on the District's website.

Executive Sessions

The Galveston Central Appraisal District Board of Directors may recess into a closed meeting (Executive Session) on any item listed on this agenda if the Executive Session is authorized under the Open Meetings Act pursuant to one or more of the following exceptions: Tex. Gov't Code §§ 551.071 (consultation with attorney), 551.072 (deliberation regarding real property), 551.073 (deliberation regarding a prospective gift or donation), 551.074 (personnel matters), and/or 551.076 (deliberation regarding security devices or security audits). The Presiding Officer of the Galveston Central Appraisal District Board of Directors shall announce the basis for the Executive Session prior to recessing into Executive Session. However, the Galveston Central Appraisal District Board of Directors may only enter into the Executive Session on any agenda item for which a separate Executive Session has not been separately posted if, prior to conducting the Executive Session, a majority of the Board of Directors votes to go into Executive Session. This motion requirement does not apply to any agenda item that has been previously noticed as constituting or including an Executive Session. The Appraisal District has proposed a budget of \$9,913,025 for the 2027 fiscal year, with an increase of \$340,254 or 3.55%. The adopted budget for 2026 is \$9,587,771. The appraisal district does not levy taxes or set tax rates. Adoption of any budget does not directly result in the issuance of any tax bill for any property.
